FTA Europe President's insights: packaging industry challenges & opportunities

In early March, Intergraf and FTA Europe consumer responsibility in properly disposing of jointly organized the Shaping the Future With Packaging 2023 conference. Sante Conselvan, President of the FTA Europe gave an interview to Cape Decision and spoke about some of the major issues facing the graphic industry and the consumer responsibility in properly disposing of and recycling packaging materials to maximize their benefits. Conselvan shared ongoing projects undertaken by FTA Europe. One significant project aims to facilitate information sharing among different associations, providing

packaging sector.



When discussing the sector's challenges, Conselvan emphasized the need to distinguish between commercial printing and publishing on one side, and packaging

on the other. While he was initially involved in the printing market, his focus has now shifted towards packaging due to its rapid adaptation to evolving consumer lifestyles. Today, packaging serves as an integral part of our lives, requiring innovative solutions to accommodate diverse consumption patterns. Conselvan highlighted the importance of education, particularly among young individuals, to promote responsible usage, recycling, and the positive aspects of packaging. Recognizing the crucial role of packaging during the Covid-19 pandemic, Conselvan stressed the necessity for a collective effort within the entire packaging community to anticipate a virtuous loop from packaging design to end-of-life recycling.

Moving on to opportunities in the packaging industry, Conselvan highlighted the growth in various segments such as flexible and rigid packaging, cardboard, plastic, and labels. These segments have witnessed shifts between materials, with a focus on new functionalities and simplified compositions. Packaging continues to adapt swiftly to meet the changing needs of consumers. However, Conselvan also emphasized the importance of

and recycling packaging materials to maximize their benefits. Conselvan shared ongoing projects undertaken by FTA Europe. One significant project aims to facilitate information sharing among different associations, providing comprehensive documentation of flexo technology and a "toolbox" of best practices. Another crucial initiative focuses on educatina about flexo technology. Given the limited number of flexo training centers in Europe, efforts are being made to encourage these centres to continue offering practical training, including summer courses and seminars. The objective is not only to impart flexo knowledge but also to keep up with the latest technological advancements.

Furthermore, Conselvan highlighted the importance of (inter)national meetings and pan-European conferences to foster the exchange of best practices and experiences. Through these platforms, collaboration and networking can extend beyond borders, with contacts established even with flexo associations in Japan, the United States, and the recent inclusion of the Polish flexo federation. "Whether it's flexible or rigid packaging, cardboard, plastic, or labels, all these segments are growing. We have seen shifts between packaging materials, from plastic to fibre, with new functionalities and simplified materials. Packaging is quickly adapting to consumer needs. However, it is important for the consumer who has benefited from the properties of packaging to also be responsible for putting it in the correct bin for recycling."

Intergraf joins the cross-sectoral Coalition on Circular Choices for the EU's Bioeconomy

Intergraf joins the cross-sectoral Coalition supporting Circular Choices for the EU's Bioeconomy to combine the advocacy efforts with partners that represent forest-based industries.



Together, the Coalition represents a sustainable, circular, and integrated European value chain which will be crucial to enable the EU to reach the net zero goal by 2050. The Coalition has already announced its 2030 policy recommendations, available here.

The Coalition is urging the EU to prioritize sustainability and a circular economy with a strong and growing supply of renewable wood

and fibre, through legislation that facilitates the transition to sustainable wood-based products and bioenergy. We recommend recognizing the value of wood as a precious resource, acknowledging renewable materials' contribution to climate neutrality, and improving the use of raw materials by applying the cascading principle. The Coalition also suggests establishing a wood and fibre-based Industrial Alliance to improve material efficiency and secure fair competition on global markets, and, in the meantime, make the EU more self-sufficient and able to withstand global challenges. The EU should recognize the contributions of Coalition stakeholders to the circular bioeconomy and regulate wood, fibre-based, and paper-based products as biobased, sustainable, and complementary recycled solutions to reusable options.

European Commission allows the removal of printed medical leaflets

The European Commission has proposed a The proposal will undergo further discussion broad reform of European pharmaceutical legislation, including a revision of the Directive on medicinal products for human use. In its proposal, the Commission grants the possibility for EU countries to allow for the leaflet to be provided only in a digital format. However, Member States that allow electronic leaflets • Proposal for a Directive on the Union code must guarantee the patient's right to a printed copy of the leaflet upon request and free of charge.

The proposal to allow for digital medical leaflets is being made through a Directive, which sets objectives for all EU countries to implement into their national legislation, allowing for flexibility in the decision of how • MLPS infographics 'Every comma has a these objectives are to be implemented.

The initiative is supposed to facilitate easier access to medicines from third European countries for smaller markets such as Malta, which has experienced significant medication shortages since Brexit, as medicines imported from the UK are subject to a different authorisation process and cannot be exported to Malta; however, the issue of providing printed copies of the leaflet to patients upon request remains unresolved, with references made to pharmacists providing a printed copy to the patient, but Intergraf contends that print-on-demand at pharmacies cannot guarantee the same level of safety as industrial-level printers.

Intergraf is preparing its detailed position on the proposal and is partnering with MLPS (Medical Leaflet = Patients Safety) to support the use of paper leaflets. MLPS is a coalition of healthcare packaging makers within the European Carton Manufacturers Association (ECMA).


